

Lake Eau Claire Protection & Rehabilitation District Update

After considerable exploration, Rod Zika advised us that the most desirable location for the new proposed sediment trap for Hay Creek is just (upstream)of the last property (Dave Moelter's home) on ND. By Brian Kellett and Mike Lea driving rebar in with a post hole driver in various locations at this site to determine how deep we can build the trap, Rod believes we have sufficient depth, width and length to install an appropriate sediment trap. (Note, no problem driving rebar in, however getting it out was a different story. Brian and Mike really got a workout.)

We have engaged Williams Engineering Services (WES) for the technical design of the trap and Rod has provided WES with the desired trap design information. The Lake Eau Claire Association is providing the funds for this engineering work and Eau Claire County has indicated that they will provide 50% matching funds.

We currently have a permit for a sediment trap located by Marc Christopher's property on Hay Creek. DNR (David Hon) has indicated that we may amend this permit to include the proposed new sediment trap.

Josh Pedersen and Jody Gindt (Eau Claire County, Parks & Forest) have selected a proposed route from the new trap to a deposit site off NL. This route is through county forest land onto County NL and then through county forest land to the deposit site. A challenge we have is aerial maps show presence of wet lands in some of the proposed road routes. David Hon (DNR) has agreed to meet with Josh Pedersen on Friday, Oct 19, 2018 to determine if we may use the proposed route in the winter time while the ground is frozen as is or do we need to implement mitigation in order to gain permission to construct this haul road. After these issues are resolved, we can request WES to survey and design the road.

After we have WES engineering designs for both the trap and road, we may apply for appropriate permits. Once we get the permits, the Eau Claire County Parks & Forest Department has volunteered to construct the road, with us paying for all rock and base material. Also, Frank Draxler, Eau Claire County purchasing agent, has volunteered to prepare and send out the bid package to dig the trap once we receive the engineering design from WES. Our goal is to dig the trap in January/February 2019.

Many thanks to all the volunteers working to accomplish this, to the Lake Eau Claire Association for furnishing funds to do this project, to Eau Claire County for the matching funds and Parks & Forest Department for road construction.

Nature Notes – Preparing for Winter By Mike Harden

We had our first frost the other night. It won't be long now and winter will be upon us. We may be putting up a wood supply, closing down our cabins, getting out our winter garb, or otherwise preparing for the change, but preparation is taking place in the natural world as well. There are many ways in which wildlife prepare for the upcoming drastic change in seasonal conditions; some simply migrate to get out of here and migrate to warmer climes. Some, like many mammals, molt to a winter coat that is much warmer than that worn in the summer, or even is of a totally different color. Others just literally "chill out" and sleep the winter away.

Birds and bats have a big advantage with their flight abilities, and many species use this to simply fly south to areas where there is more food that is to their liking in the winter. Some, like the American woodcock (a worm eater) have such a limited dietary preference that they simply would starve in a Wisconsin winter. Many, like the orioles and hummingbirds have mostly left already. Some, like the tundra swan, come through later, peaking about in mid-November as they journey from the Northwest Territories to their wintering grounds on Chesapeake Bay. Keep your ears tuned to the skies during this time, as their flocks are quite spectacular, and their primary migration route centers right over Eau Claire Co., then down around the tip of Lake Michigan and eastward.

If you are earthbound, like most mammals and other animals, other adaptations are in order. The snowshoe hare, and our three species of weasel in Wis.: the least, the short-tailed, and the long-tailed weasels all turn a beautiful pure white in winter, helping them to avoid predators during this time.

Another strategy for surviving the privations of winter is to try to sleep through it. Many species enter a period of dormancy or inactivity, the depth of which varies from one species to another. To most of us, the term "hibernation" is adequate to describe this condition, although the level of inactivity can vary considerably.

Black bears, for example, enter a "winter sleep" in which their body temp drops from around 98 to 91 degrees F., and their heart slows to 10 beats per min or so. A bear can be awakened. A woodchuck is very difficult to arouse during hibernation, as their temp may drop to around 38 deg. F., and their heart down to 5 beats per min. Snakes, frogs, and turtles also seemingly disappear during the winter months, entering into states of dormancy which vary by species.

We humans, being the most adaptable of all species, have a choice. We can fly south (if you can afford it), we can change our outer garb (sometimes using the pelts of furbearers), or we can enter a period of winter dormancy in front of the TV. (Go Packers)!!

OVER THEY GO! – by Fred Poss

Saturday, September 8, turned out to be a perfect day for installing more fish cribs in our wonderful lake. A crew of about 20 volunteers showed up at the North Boat Landing and got to work around 8:30 AM. As the saying goes, “Many hands make the work go fast.” Within two hours and with great cooperation among the crew, we were able to install 17 new cribs. This year we are trying a little different approach—we are using hardwood limbs about 8 feet long that are fresh cut and still leafy, instead of white pine branches. The hope is that oak, maple, and other hardwoods will last a bit longer. In all, after our installation day, there are presently 448 fish cribs and tree falls in the lake.

In mid-October, Robin Walsh has plans to install about 31 more tree falls, which would bring our total to 479. While these numbers may seem like overkill, please remember the cribs we build are small single log size units, not the big log squares that many people assume we make. Furthermore, when we first started the program in 2012 to rebuild the lake’s fish and minnow population, you may recall that we set our goal at 500 cribs for the lake by the year 2020. Everyone on our lake should take real pride in knowing we will easily reach our goal providing we are able to continue gathering volunteers. As plans shape up now, it appears we will only need to do one Saturday morning installation per year of about a dozen cribs each time.

Many thanks go out to all the folks who helped make the crib installation another success: James Tumm, Lou Mason, Jeff Eckwright, Greg Steinacher, Chris and Kanyon Fellers, Dale Zank, Rod Zika, Don Russell, Scott Braun, Dan Marcheske, Mike Harden, John Selz, Mike Lea, Marlo Orth, Rick Lawson, Glenn Johnson, and others who also pitched in and helped in various ways.

Get the Lead Out

As an avid duck hunter, I am curious and concerned about the health and future of waterfowl. Knowing there is a history of lead poisoning in these birds, I was curious to investigate if ducks were still unknowingly consuming significant amounts of lead.

I along with two other Wildlands Charter School students conducted a lead poisoning test on harvested bird gizzards. We saved all of the gizzards we shot this year so we could open, clean, and examine them. We examined the tissue and the gravel that helps grind up the bird's food. We were looking for signs of damage to the gizzards due to lead poisoning from shotgun pellets, sinkers, and other lead pollution in waterways.

Our methods included carefully examining each gizzard and documenting indicators such as lead pellets or dark gray tissue in the gizzard. Healthy waterfowl gizzards are green and rough, with a hint of pink color. Darker, mushy tissue indicates signs of lead damage.

The gizzards collected from the Lake Eau Claire watershed area had measurable evidence of lead damage; such as soft gizzard tissue and lead shot pellets in the organ. Other signs we looked for included bright green staining of the vent area and heads that appeared puffy and swollen. These birds can be mistaken for crippled and injured, but in fact the lead is just taking effect. The seabirds we examined from Maine appeared healthier than the Wisconsin birds; with little evidence of lead poisoning. Our findings suggest waterfowl in the Lake Eau Claire area are still suffering from lead exposure and damage.

Lead can contaminate fish that certain waterfowl eat. We were surprised to learn from our research that of all the Wisconsin birds, the Bald Eagle was the most commonly affected by lead poisoning. Lead makes birds' reproductive systems fail over time, which in turn impacts their population and ultimate survival rates. The most common way wildlife in Wisconsin consumes lead is from shotgun pellets and sinkers. Our findings suggest there is still lead in our waterways. Not only is it in our lakes, it is getting into wildlife. One-way hunters and anglers can help is to use steel shot and sinkers instead of lead. This would make a tremendous difference in the health and longevity of waterfowl populations.



WALLEYES GALORE! – by Fred Poss

In previous articles, I have discussed the terrific results of fish population increases since 2012 because of our aeration system which provides access to deep oxygenated water for gamefish in the summer and because of our long-term commitment to add coarse, woody habitat to the lake in the form of single log fish cribs. You may recall I have also pointed out how the typical walleye lake in Wisconsin, according to DNR numbers, has an average of 2.5 adult walleyes per acre (fish that are of breeding size of 15 inches or larger). And I have also shared recently that after our aeration system went to work and the fish cribs starting doing their job, Lake Eau Claire now has an average of 5.3 adult walleyes per acre—making it one of the finest walleye lakes in the state of Wisconsin, especially considering its small size. Certainly, too, releasing walleye of 18 inches or larger has made a real improvement because it allows the prime breeding size fish to remain in the lake.

But this week, we received some fantastic news from the DNR. Joe Gerbyshak, our area's fish biologist, conducted a survey of young-of-the-year walleye on Lake Eau Claire on the evening of October 2. Joe reports that the 2018 young walleye class is extremely strong. His crew found 148 young walleyes in a mile sample. He says, "This is one of the biggest—if not the biggest—year classes recorded on Lake Eau Claire." He believes this year's hatch of young fish should help to make good fishing for years to come, once the fish grow to legal size (about 4 or 5 years). He went on to say, "All the habitat work that you (Robin Walsh with tree drops) and the Lake Association (fish cribs) have been doing looks like it is really paying off."

This is just one more strong piece of credible evidence that we are on the right track with our efforts to rehabilitate and improve Lake Eau Claire. Let's keep keeping on!




